I think I know what is missing. The internal layout/ floor plan from The Marijuana Checklist Item 13 mentions the following along with the site plan.

I have attached the internal floor plan along with the explanation of each item to my best abilities. Please accept exhibit M internal floor plan/ Layout.

1. Indoor employee only area- Please refer to the attached floor Plan Exhibit M (Laboratory Area)
2. Public access area,- Please refer to the attached floor Plan Exhibit M (Reception Area)
3. Storage- Please contact the Police Chief or Fire Chief for a submitted security plan for viewing only and not disclosing the information. Unable to provide because of open meeting law, cannot be disclosed to the public and against security guidelines.
4. Preparation- exhibit M (Laboratory Area)
5. Waste disposal -Satellite Waste Area, Exhibit M (secured, designated containers within Laboratory Area with secondary containment)
6. Administration- Exhibit M office area
7. Transportation- Courier's will be bringing in samples through the front door using front parking space. Please refer to Site Plan
8. Loading - no products being shipped out, Supplies for the lab will be dropped off and received in person in the rear parking area via the rear door, Please refer to the site plan
9. Parking area -Please refer to site plan.

There will be a door installation between the reception area and Laboratory area with access control separating the reception area with the laboratory area.

Furthermore, I would just like to update the planning board on today's event. The CCC has just approved a Provisional License for G7 Lab LLC and would be happy to provide documentation once I receive it. I believe this would be an update on item 2, on the Adult Use Marijuana checklist.
