

M.G.L. Chapter 40A, Section 11. "In all cases where notice of a public hearing is required notice shall be given by publication in a newspaper of general circulation in the city or town once in each of two successive weeks, the first publication to be not less than fourteen days before the day of the hearing and by posting such notice in a conspicuous place in the city or town hall for a period of not less than fourteen days before the day of such hearing. In all cases where notice to individuals or specific boards or other agencies is required, notice shall be sent by mail, postage prepaid. "Parties in interest" as used in this chapter shall mean the petitioner, abutters, owners of land directly opposite on any public or private street or way, and abutters to the abutters within three hundred feet of the property line of the petitioner as they appear on the most recent applicable tax list, notwithstanding that the land of any such owner is located in another city or town, the planning board of the city or town, and the planning board of every abutting city or town. The assessors maintaining any applicable tax list shall certify to the permit granting authority or special permit granting authority the names and addresses of parties in interest and such certification shall be conclusive for all purposes. The permit granting authority or special permit granting authority may accept a waiver of notice from or an affidavit of actual notice to any party in interest or, in his stead, any successor owner of record who may not have received a notice by mail, and may order special notice to any such person, giving not less than five nor more than ten additional days to reply."

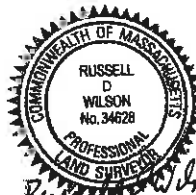

Pursuant to MGL Chapter 40A, §15, please accept the attached documents, papers and comments constituting the record of the case in which the above noted appeal is being taken.

4 Lincoln Drive

A Building Permit # 264-12 application was received and approved for the construction of a single family home with restrictions. Restricted from the issued permit was the construction of an open deck which would have encroached onto the required rear setback. Furthermore, it is noted that the plot plan submitted for this appeal shows a new porch also within the required setback from the street front.

As such the applicant is seeking relief from the zoning bylaw allowing for the construction of an open deck on the rear and a new porch on the front of the "in-progress" single family dwelling. Unless the applicant prevails before the Board of Appeals, final occupancy will limit the construction of the home in compliance with current Zoning setback of 15 and 30 feet respectively.
