Good Morning Maren,

I hope you had a great summer! We signed an amendment to extend the hours of operation last September to implement the following hours:

Approved Amended Hours of Operation - 8 Hours/Week Added

Sunday & Monday - 9am to 9pm (no change from original special permit)

Tuesday & Wednesday - 9am to 10pm

Thursday - Saturday - 9am to 11pm

Based on this approval, we ultimately exercised the following hours of operation which are our current hours of operation:

Existing Hours of Operation - 3 Hours/Week Added

Sunday & Monday - 9am to 9pm (no change from original special permit)

Tuesday & Wednesday - 9am to 9pm (no change from original special permit)

Thursday - Saturday - 9am to 10pm (added 1 hour to closing instead of 2 permitted hours)

We are seeing a need to extend our hours by 1 hour on Sundays and Mondays so this would put us at a closing time of 10pm instead of 9pm.

We have been approved with the amended permit for almost 1 year and only ultimately exercised 3 hours of operation to the week, opposed to the approved 8 hours of operation to the week.

We would like to propose to the Planning Board that we be able to extend our Sunday and Monday hours to close at 10pm, which would ultimately add 2 hours per week to our existing hours of operation creating a total of 5 hours added **(still 3 hours less than what was previously approved)**.

Can you please share your thoughts on this? I'm also happy to jump on a quick phone call if needed.
