REFERENCE PLANS: K137E/L138E ACR and 337 Rebuild, dated July 15, 2025, prepared by Vanasse Hangen Brustlin, Inc., issued for Permit Set, to be amended to resolve peer review and Conservation Commission permitting requirements:

PUBLIC HEARING: The Littleton Planning Board held a duly advertised public hearing on the above dates to consider the application of New England Power Company for a Stormwater Management Permit in accordance with the Code of the Town of Littleton, Chapter 38, Article II Stormwater Management and Erosion Control.

The Public Hearing was closed on August 7, 2025.

Certificate of Decision – National Grid Project (K137, L138, 337 Right-of-Way Easement)

VOTE

At the meeting held on August 7, 2025, a motion was made by *Baker* and seconded by *Montanari* to **approve the Stormwater Management Plan** applications listed above in accordance with the Reference Plans and subject to the following **conditions**. The following conditions shall be binding upon the Applicant and its successors and assigns. Failure to adhere to these conditions shall render this Stormwater Permit null and void, without force and effect, and shall constitute grounds for the revocation of this permit, and of any building permit issued hereunder. The Town of Littleton may elect to enforce compliance with this Permit using any and all powers available to it under the law. Revocation of this permit would require notice to the applicant and a Public Hearing and other applicable requirements of the law.

General Conditions:

1. Electronic copies of final plans must be provided prior to commencement of any site work and/or construction activity on site.
2. All Peer Review comments from Green International dated 8/7/2025, must be resolved to the Planning Board's reasonable satisfaction, prior to commencement of any site work and/or construction activity on site.
3. All comments regarding work performed near the environmentally sensitive areas must be resolved to the Littleton Conservation Commission's reasonable satisfaction, prior to commencement of any site work and/or construction activity on site.

Conditions applicable during construction:

4. All construction traffic shall be coordinated considering school bus stop areas and other locations where existing homes could be impacted by construction traffic.
5. All phases of construction shall be done to minimize noise, odor and dust that would be injurious of public health and/or cause a “condition of air pollution”.


